Post Office Projects is dedicated to furthering artistic practice and experimentation through the presentation of work by early to mid-career artists and curators. Supporting them to take the next big step in their career by providing spaces to experiment and test ideas.

There are two exhibition spaces – the Gallery and Vestibule, programmed through a combination of invitation and open call. Supporting critical engagement with each exhibition will be a public program of artists talks.



# **Exhibtions**

#### POST OFFICE PROJECTS WILL PROVIDE

- Installation & curatorial support.
- Artist fees inline with NAVA recommended rates.
- Artworks will be covered by the Post Office Projects contents insurance up to the value of AUD \$15,000.
- Media release and publicity.
- Listing the exhibition on the POP website.
- Gallery sitters.
- Advice and support for grant writing.
- Digital invitation sent to the mailing list.
- Artists will have two weeks between exhibitions in order to install their work, this time includes the de-installation of the previous exhibition.
- Cover all opening night costs including a bar, volunteer staff, and liquor license
   Openings are typically held on the first
   Sunday of the exhibition period.

### ARTISTS/CURATORS WILL PROVIDE

- High quality artworks ready to be installed during the assigned installation period.
- Artists must hold their own public liability insurance. They are responsible for contacting the Director with a reasonable amount of time if artworks are potentially dangerous or high risk, flammables, consumables, sharp implements or objects that may endanger the audience.
- Must sign a contract with POP outlining all responsibilities, expectations and pay a \$100 refundable security deposit.
- Photos, biography and brief artist statement for promo six weeks prior to opening night.
- Artists will provide regular updates to the Director regarding the development of their work. These may take the form of a studio visit, phone call or email. They may include providing progress images.

### CODE OF CONDUCT

Post Office Projects is a space that values respect, community, communication and experimentation. While we aim to create critical dialogue between our artists and audiences, we do so in a safe, accessible and welcoming space for all our communities and audiences. Any applications that contain artworks or behaviours that are threatening, demeaning or may isolate social, cultural, marginalised or racial groups will not be accepted. This includes sexism, homophobia, transphobia, classism and ableism. Any persons or exhibitions violating this code will be removed from the premises.



# **Selection Criteria Process**

Quality of the past artwork or works-in-progress

Demonstration of innovative, challenging, experimental and critically-engaged artistic and curatorial practice

Potential for the exhibition to further the careers of the artists, curators and those involved.

There is no fee to exhibit at Post Office Projects. Exhibiting artists will present an artist talk open to the public and suggest a title for the Art x Fiction Library. The Director will work with exhibiting artists to provide curatorial feedback throughout the development of the exhibition, and to support grant applications.

- → Artist biographies For curators and group exhibitions, you may include an additional document with artist biographies for each of your participating artists (max. of 2 pages as a single pdf)
